

EASPD Provider Forum Greece

Athens, 29/10/2015

Narrative Report

1. CONTEXT

This Provider Forum was the follow up of last year's successful Provider Forum in Athens in November.

The Provider Forum was organized in combination with the final Conference of a project implemented by ESTIA with topic: Human Rights in Practice.

This time the PF was organised to bring together different stakeholders in the disability sector to highlight the importance of implementing Human Rights. The aim was to point out how you can proceed from theory to practice.

An importance issue was to inspire service providers to join networks and through them make the difference for people with disabilities.

Greece is in the middle of a very difficult period of financial decrease and the importance of networking and cooperating through EU programmes with organisations from other countries is of more importance than ever.

Everybody has to be alert on the danger of cut downs in the social security sector. This will make the people with disabilities even more excluded from the society.

The importance of highlighting the implementation of the rights for people with disabilities and especially people with disabilities is most significant.

2. PROVIDER FORUM PROGRAMME AND DISCUSSIONS

The Provider Forum was attended by representatives from important stakeholder groups: central authorities, regional authorities, local authorities, employers, parents, people with disabilities and representative from the Council of Europe, European Network, national funding foundations and the ombudsman for people with disabilities and service providers.

In the first part of the forum, with speakers: the President of EASPD Mr. Wolfmayr, the President of the Committee on the Rights of Persons with Disabilities of the Council of Europe Mr Nikolsky, the Special expert in the field of social protection of the Ombudsman, Ms. Skyllakou, the Expert by Experience Ms. Kotti trainee of Estia and the Director of Estia Mr. Kasimatis issues related to the provision of services to strengthen the rights, the strategies of the Council of Europe for the protection of the rights of persons with disabilities, accessibility issues for people with disabilities to social benefits and personal experiences of disability were discussed.

More specifically the main speakers and their topics were:

- Franz Wolfmayr (President EASPD): "Services as enablers of rights".
- Dimitrios Nikolsky (President of the Committee on the Rights of Persons with Disabilities of the Council of Europe): "The challenges and opportunities ahead" The Council of Europe's strategy for the protection of Human Rights of pwd.
- Evangelia Skyllakou, (specialist in the field of social protection of the Greek Ombudsman): "The difficulties of accessibility for pwid to social services".
- Maria Kotti (Expert by experience ESTIA): "Talking about my disability"
- Vasilis Kasimatis (Director ESTIA): "Delayed rights ceases to be rights"

In the second part of the forum with speakers on the panel the Mayor Filothei-Psychiko, The head of International Relations POSGAmeA, President of EASPD, the Social Worker of the Division of Social Solidarity of the municipality of Athens and the head of Human Resources at AB Vassilopoulos SA (a chain of Supermarkets) answered questions raised by self-advocacy groups of trainees from ESTIA and the Theotokos Foundation (Interactive Debate).

The PF ended with a business lunch in which networking capabilities and communication needs between Greek organisations and the European Association of Service Providers for persons with Disabilities (EASPD) were discussed.

3. OUTCOME AND FOLLOW-UP

The representatives of the service provider organisations expressed their interests and their needs to being involved in networks both in national and international level.

The strength of cooperation over the borders is the only way of reaching the target of changing attitudes and way of working.

The influences and exchange of Good practices between organisations is the road to changing the situation for people with disabilities.

Several of the service providers' organisations took the decision to join the EASPD network.
