EU AND YOU



The European Citizens' Initiative: collect 1 million signatures and ask the European Commission to legislate in the field you proposed!

Starting from the 1st of April, a new instrument of participatory democracy at the EU level will enter into force: the European Citizens' Initiative (ECI). The ECI is a new tool allowing European citizens to collect at least 1 million signatures in 7 different countries in Europe aiming to invite the European Commission to come up with a legislative proposal.

The idea of establishing an ECI finds its rationale in the Treaty of Lisbon article 11 (TEU) and then in the approved Regulation 211/2011. This is a great opportunity for civil society organisations and European citizens to make their voice being heard by proposing the European Commission to take actions in a field where the European Union is competent.

Despite the specific requirements at national level, with different national requirements, there is optimism on the use of this instrument: for the first time in Europe there will be a real transnational participative democratic tool enabling and empowering citizens to participate in the European legislative process since its start.

What about satellite assistance for people with disabilities?

Find out more about our INCLUSION project aiming to create a satellite navigation device for people with motor impairments, based on Galileo technologies.

Despite some initial difficulties, Market Trials took place from 19 to 30 March, i.e. the testing of a prototype resulting from the joint efforts of technical partners in the project and EASPD. 8 volunteers tested the satellite navigation system for 2 weeks provided project partners with their feedback. Freedom of movement is a key concern in the disability sector, EASPD and its partners hope that the project will represent a significant step forward in exploring the opportunities offered by new technologies for the benefit of disabled persons.

The Rix Centre at UEL kicks off the "Klik in" pilot

DEVELOPING WEBSITES FOR PEOPLE WITH INTELLECTUAL DISABILITIES



The 20th of March saw the first group training session for Teachers and SLP staff at the Rix Centre in the framework of the W2ID project. Seventeen staff members attended the pilot which it was introduced with presentations, video clips and hands on experience of making an easy-build Klik in website together. Ajay Choksi, a young man with intellectual disabilities who works at the Centre, presented some of his own website building work, demonstrating the way he started with producing personal content. Ajay's advice website (see: link) provides information on subjects like safety in the community, travel, work and love presented in visual form with easy-read sentences. It helped the trainees see the type of material that might emerge from the project with their own learners. Ajay's video on the introduction to his website features his advice for other young people with intellectual disabilities who might be interested in making their own website on independent living: 'You can do it and you can live it!'

Attendees came from 3 different East London Schools, 2 Local Authorities – who will be engaging adult volunteers and advocates on the Pilot – and from two Community learning Centres that provide vocational training and support for adults with ID in the community.

Surprisingly, the majority of the participants had already had some experience in using digital media as part of their learning activities. This did not reduce their enthusiasm for taking on "Klik In", as they saw the added value of a system that provides an organised structure with learning resources and a website-building software package that would simplify the process.

EGDMS (European Guide Dog Mobility Standards): helping achieving freedom of movement for all in Europe

EGDMS has the objective to develop a European reference model for the training of Guide Dog instructors. Why this? Because today blind or visually impaired people do not have any mean to assess the quality of the guide dogs they might wish to get to support them daily, except in some countries were nationally accredited curriculas have been developed and used for years. The project is taking as a basis the well-tested training system existing in the UK (under the lead of Guide Dogs for the Blind Association), adapting its contents to build up a European-wide reference model. In parallel to the project, CEN (the European Standardisation Committee) has initiated a dedicated workshop, which should result in a broadly accepted framework that can be used in any EU country as a basis for curriculas matching the National and European Qualification Frameworks. On 20 September, the EGDMS final conference will take place in Brussels, bringing together project partners and key stakeholders. Registrations will soon be open! We will kee pyou informed...

The content of the training programme is currently under development and will be finished by end of September 2012. Before its completion, a national expert meeting involving representatives from self-advocacy groups, experts from service providing organisations for persons with disabilities as well as experts from educational institutions will be organized in order to get feedback and recommendation on articles of the UNCRPD and skills to be trained on. Ultimately, the training will be implemented in October 2012 in four countries: Bulgaria, Germany, Hungary and United Kingdom.

ASPA Housing Services Foundation: independent living first!





The ASPA Housing Services Foundation was founded in 1995 by thirteen Finnish NGOs. It represents several disability groups, including people with mental health condition, physical disabilities and learning disabilities. ASPA activities are partially sponsored by public funds.

The mission of the ASPA Housing Services Foundation is to promote opportunities for people with disabilities and people with mental health condition to live an independent and autonomous life in their home as well as in the service they use. ASPA develops tailored, high-quality and safe living solutions in ordinary residential environments. In general ASPA strives to influence the design and construction of housing and local communities' environment so as to treat the needs of all members of the society equally.

ASPA houses are rented to people with physical or mental conditions who need assisted services to be able to live in an ordinary urban or rural neighbourhood. The service user is involved in the acquisition process of his / her new home. Services are provided by the municipality where the person is living with a separate agreement either by ASPA or by other providers winning the public tendering for this service.

ASPA purchases demesnes, maintains and renovates them for the community's good. It develops activities regarding various aspects of housing and services for people with disabilities as well as it assists professionals and stakeholders in the field with information and knowledge on independent living solutions.

The main challenge faced by ASPA today is to maintain the market share in competition with bigger and business-oriented companies. In Finland, many NGOs have a relatively long history and tradition in providing services for people with disabilities. The future of this long and often inherently client-oriented service tradition is at stake: NGOs are losing their importance in providing services to people with disabilities vis-a-vis private business-oriented companies gaining shares in the market.

The influence of NGOs in a free market should be based on the quality of services concept in connection with the long run profitable investment for the community. Short-term savings turn out to be really expensive in the long run, especially with the current increasing need for service users' health care and social care. Further information: link
